Abstract

The general objective of the FuTuRE project has been to prevent and combat gender-based violence, with a specific focus on women victims of intimate partner violence (IPV) and multiple discrimination, and to support and protect victims of such violence, by updating and strengthening risks assessment methodology, procedures and risk management strategies.

The event in Brussels will be the occasion to present and share the main project results, in order to advocate for further political commitment at EU level and develop recommendations aimed at strengthening multi-agency and multi-level cooperation in the countering of male violence against women, as well as for future replicability/scalability of the project.
